Minutes of the Cando City Council

The Cando City Council met Tuesday February 16, 2021 at 5:00 pm at the Towner County Courthouse with Mayor Bjornstad presiding. Councilors Olson, Holien, Weber, Bjornstad and Shock were present. Councilor Gibbens was absent.

Motion by Councilor Bjornstad was seconded by Councilor Weber to approve the updated Agenda, all voted aye. Motion passed.

Motion by Councilor Holien was seconded by Councilor Olson to approve the minutes from previous meeting, all voted aye. Motion passed.

Visitors: No visitors were present.

Old Business: Scott Gable talked about the lift station. He has exercised all the valves, except the lagoon, which he will do when the weather is nicer. Keith Hegney from ND Rural Water Systems Association came up to assist and make sure all was in working order. Outside of some normal corrosion, all looked good and there is no need for any replacements at this time.

Mayor Bjornstad talked about the industrial park. Moore Engineering submitted a proposal for land surveying to be executed within four weeks of acceptance. Short discussion was had about size of lots and measurements. Once the sewer line is mapped out, lots can be determined by the city at that time. Councilor Shock made a motion to accept the estimated \$9730 proposal from Moore Engineering for land surveying services. Councilor Olson seconded the motion, all voted aye. Motion passed.

The city council acknowledged an email from the owners of Gordy's Bar requesting the gaming site authorization by Park River Fire Department will be tabled until they return in April.

The lift station on 7th St W will need a new alternator. AE2S has estimated it to be about \$500. No action at this point.

New Business: The Spring Workshop offered by ND League of Cities for elected and appointed officials is April 20-21, 2021. Amanda will be attending. All council was encouraged to check out the agenda and website to see if any professional development opportunities fit their interests and availabilities.

A gaming permit request from Cando Hockey Boosters was submitted. Motion by Councilor Shock to approve the gaming permit for Cando Hockey Boosters was seconded by councilor Weber. All voted aye, motion passed.

Financial Report: The City Auditor presented the Financial Report for January 2021.

Motion to pay the bills was made by Councilor Olson, seconded by Councilor Bjornstad; all were in favor and motion passed.
