Minutes of the Cando City Council

The Cando City Council met Tuesday July 6, 2021 at 5:00 pm at the Towner County Courthouse with Mayor Bjornstad presiding. Councilors Holien, Gibbens, Olson, Bjornstad, Weber and Shock were present

Motion by Councilor Weber was seconded by Councilor Shock to approve the Agenda, all voted aye. Motion passed.

Motion by Councilor Bjornstad was seconded by Councilor Gibbens to approve the minutes from previous meeting, all voted aye. Motion passed.

Visitors: Gene Pennell was present to discuss the utility bills, especially the garbage rates. After a lengthy discussion, the Mayor stated that the rates will be reviewed when the budget is being prepared, which will be at the end of July. The Mayor stated that the City Building Inspector has to deem the houses dangerous before any action can be taken. Councilor Olson said he would contact Derrick Childs.

Old Business: Residents that had expenses due to sewer issues at 2nd Ave (Culdesac) have not been reimbursed by Hydro-Klean. Mayor said he would call on it again this week.

Jason Corday requested to the Council to purchase 2 lots in the Industrial Park. Councilor Gibbens made a motion to accept Corday's request to purchase lots 4 & 5 in the Industrial Park. Councilor Olson seconded the motion, all Councilors voted aye and motion passed.

New Business: Cando Bar owner applied for an Off-premise liquor license. Motion by Councilor Weber was seconded by Councilor Shock to approve. All Councilors voted aye and motion passed.

Terracon Consultants (of the TCMC Expansion) sent the City a certified letter to complete an Intergovernmental Review, Mayor Bjornstad stated that he would take care of it.

Councilor Weber resigned her seat on the City Council, since she will be moving out of City limits. This meeting will be her last. The Mayor thanked her for her years of service on the City Council.

Councilor Shock made a motion to approve payment of the bills, Councilor Bjornstad seconded, all voted aye and motion passed.
